

INVITATION TO BID

SEALED BIDS for the furnishing of the necessary materials and construction of the

2011 MAINTENANCE PROGRAM  
WOOD COUNTY BOARD OF MR/DD

will be received by the Wood County Board of MR/DD, Administrative Offices, Entrance B, 1921 East Gypsy Lane Road, Bowling Green, Ohio 43402, until

11:00 AM (Local Time)  
Friday, July 29, 2011.

At that time, bids will be publicly opened and read aloud in Conference Rooms 2/3 of Wood Lane Industries, Entrance D.

The scope of work consists of applying an asphalt pavement seal coat to over 30,000 square yards of existing pavement at various Wood Lane facilities. The work also includes minor quantities of full-depth asphalt repair, concrete and curb repair, as well as related work.

The contract documents, including plans and specifications, are on file at the office of the Wood County Board of MR/DD, and the Engineer -- Poggemeyer Design Group, Inc (PDG). A set may be obtained from PDG. A non-refundable deposit in the amount of \$35, will be required for each set of plans and specifications; checks made payable to Poggemeyer Design Group.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **2011 MAINTENANCE PROGRAM** --- and addressed to Donna Beam, Director of Operations, Wood County Board of MR/DD, 1921 East Gypsy Lane Road, Bowling Green, Ohio 43402.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Wood County Board of MR/DD, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to

the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Wood County, Ohio.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

The Wood County Board of MR/DD reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.

The estimate for the cost of construction is \$62,900.00.
